

Height Gate booking conditions

Height Gate offers simple camping-barn style accommodation for group use. We are trying to keep the booking conditions as simple as possible, too.

1. Height Gate is for private use only by bona fide groups. Public events are not permitted. Maximum group size is 30-40, for both fire safety and facilities provided. Please note that there is only 1 male WC, and one shower for the whole building. Also, space is limited, but there is a camping field as well as the 3 sleeping rooms in the house.
2. We are sorry but Height Gate cannot be used as a venue for a gathering the main focus of which is a 'Party', and where there is a risk of invitations being given to individuals who are not part of the group making the booking. The isolated position of Height Gate has in the past made it attractive to 'hangers on' who have caused extensive difficulties.
3. The person making the booking must be at least 25 years old and is responsible for any damage caused (a £100 bond is required in addition to the booking fee – see booking form), and for ensuring that the group size is known in advance and not exceeded. A second adult aged at least 25 must also be named on the booking form, and both named people must be present throughout the visit. (N.B. Separate arrangements are available for Woodcraft Folk DFs – please contact the Bookings Secretary).
4. Please note that no amplified music, indoor smoking or dogs (except guide dogs) are permitted.
5. It is an important booking condition that the parking instructions supplied for each booking must be passed to all people in the group who will be driving vehicles, and must be followed. The access track is fairly steep and rough and in any case there is parking for only two vehicles at Height Gate. Most visitors usually walk up (about one mile). Our visitor notes clearly indicate where cars can and cannot be left at the bottom – please observe these.
6. Normally, we expect groups using Height Gate to arrive and depart together. If, for any reason this is unlikely to be the case for your booking, you must explain in advance.
7. One adult member of the party must be appointed as responsible for safety issues whilst your group is at Height Gate, and make themselves familiar with the safety advice sheet provided with each booking. You must supply us with the number of a mobile telephone which will be switched on throughout your stay, in case we need to contact you.
8. The person making this booking is responsible for ensuring that adults and children in their group use the building with care and respect, and do not by their behaviour cause problems or disturbance to Height Gate's neighbours or to members of the public.
9. Space heating is mainly by two biomass wood pellet stoves (one of which also heats the water when it is running). The accommodation charge includes fully filled stoves plus a spare sack of pellets for each. If you need/choose to use more

pellets from our store, there is a charge per sack used for which we ask you to leave cash or cheque in our honesty jar on the kitchen mantelpiece. This saves the time and inconvenience of us having to invoice you afterwards! Thank you.

10. Height Gate must be left in a clean condition on departure. You are responsible for removing all of your group's food and rubbish.
